Dear Friends,

Don't forget to vote TOMORROW, Tuesday, November 6, 2012. Polls are open from 6:00am-7:00pm.

IMPORTANT: Your Polling Place May Have Changed.

Since every precinct was redrawn after the spring primary, where you vote and your precinct number may have changed. Call our office at 773-348-9500, or click [here](#) or [here](#) to find your polling place.

Need a ride to the polls? Call our office at 773-348-9500 - we may be able to help.

You do not need an ID to vote on Election Day in Illinois unless you are voting from a new address. If the Election Judges have no record of your voter registration, but you believe you are registered to vote in your precinct, ask to cast a "Provisional Ballot" The Board of Elections occasionally makes a mistake and removes a registered voter from the rolls.

Many people have asked me for recommendations for voting, especially for the referenda on the ballot and judges. Here are my recommendations. You may print this out and take it to the polls.
