I am writing to invite you to join my office and the Sheffield Neighborhood Association (SNA) at a community meeting regarding a Special Use application for 2154 North Halsted Street to house a high-end liquor store at this location. The current occupant is a clothing store operating on a month-to-month lease, and will shortly be vacating the location in question.

The underlying zoning of the structure has a B3-2 designation, which allows the establishment to operate provided they receive a Special Use granted by the City of Chicago's Zoning Board of Appeals (ZBA). I requested the applicant participate in a community meeting prior to their appearance before the ZBA for them to receive further community feedback.

My office will be present at this meeting to monitor the discussion, take notes and record your comments.
