

Construction Update: Wrightwood Water Project and Burling Sewer Project

The long water main replacement project on Wrightwood and Schubert is coming to a close, but a sewer project on half of the 2500 block and the whole 2600 block of Burling, the 700 block of Schubert west of Burling, and the 2700 block of Orchard is just beginning.

In response to our concerns, and due to the duration of the water main replacement project, the Water Department is accelerating the construction to limit the impact on our neighborhood. The Commissioner of the Department of Water Management has assured us of the following:

- The construction in the intersection of Burling and Wrightwood will be done this Friday, September 13th to ensure that Wrightwood is clear as soon as possible to ease school traffic at Alcott Elementary and the St. Clement School;
- The sewer main on the 2600 block of Burling will be replaced by next Friday, September 20th;
- The sewer main on the 700 block of Schubert will be replaced by the following Friday, September 27th;
- They will coordinate closely with our office and homeowners to ensure that contractors take care of potential damage to parkways.
