Life Safety Ordinance Update

The Emanuel Administration announced today that information on the Life Safety Evaluation (LSE) status for hundreds of highrise residential buildings will be made available online. Starting this afternoon, residents will be able to search for specific residential buildings required to submit an LSE report in order identify their status at <u>data.cityofchicago.org</u>. information will be updated monthly.

The Chicago Life Safety Ordinance was passed in 2004 to improve fire safety standards in high-rise buildings eight stories or higher. Because the Chicago building code has since 1975 required new high-rise residential buildings to be constructed with sprinkler systems, the Life Safety Ordinance mostly impacted high-rise residential buildings constructed prior to 1975. It requires owners of these pre-1975 buildings to file a report, called the Life Safety Evaluation, which provides information on the current life safety elements of the building as well as any plans needed to meet requirements for fire safety. Get Your Senior Sewer Rebates In By March 1st!

The City of Chicago provides a \$50 annual refund to seniors on their sewer bills. The following are the requirements that must be met in order to be eligible for the Senior Sewer Rebate:

- You must be 65 years of age, or older, as of January 1 for the year you are applying.
- You must be the sole owner, owner in joint tenancy, or tenancy in common of the property.
- You must occupy the property as your principal place of residence.
- You must own a townhouse, condominium unit, or cooperative apartment that shares a common water bill.
- Residents who have previously participated should expect to receive their renewal application from the Committee on Finance.
